

**PARID General Membership Meeting
October 16, 2004
Wilkes-Barre, PA**

The annual General Membership Meeting of the Pennsylvania Registry of the Interpreters for the Deaf was held October 16, 2004, at the Genetti Hotel in Wilkes-Barre, PA. Bylaws Revisions

Motion # 2004-18. That all of the revisions to the bylaws proposed by the bylaws committee be accepted in their entirety. **Rationale:** Voting on the bylaws revisions in their entirety would expedite the process. Bylaws Committee / **Motion Failed.**

Motion # 2004-19. That “state” be deleted from Article I Name. The Name of the organization should read: Pennsylvania Registry of Interpreters for the Deaf (PARID). **Rationale:** The organization is PARID not PASRID. Bylaws Committee. **Motion Carried.**

Motion # 2004-20. That “(non-certified)” be deleted from Article III: Membership, Section II: Eligibility, 2. Associate Member. **Rationale:** This parenthetical is repetitive and not necessary. Bylaws Committee. **Motion Carried.**

Motion # 2004-21. That “, and is a student member of RID, Inc.” be added to the end of Article III: Membership, Section II: Eligibility, 3. Student Member. **Rationale:** As an affiliate of the national organization PARID should be encouraging membership in the national organization. Bylaws Committee. **Motion Failed.**

Motion # 2004-22. That “D. District Chapter” be added to Article III: Membership, Section I: Definition, 2. Non-voting Member. **Rationale:** The district sub-chapters of PARID do not currently have any accountability to PARID. This membership category would make the PARID district sub-chapters accountable to PARID. Bylaws Committee. **Motion Failed.**

Motion # 2004-23. That “Section V: Change of Membership Category. A member who as a change of membership category shall immediately be entitled to the privileges thereof. Beginning with the next fiscal year, all dues, fees, and assessments for that member shall be based on the new category.” be added to Article III: Membership **Rationale:** PARID would like to make this assumption clearly explicit. Bylaws Committee. **Motion Carried.**

Motion # 2004-24. That “Section VI: Liabilities of Members. No previous, current, or past member of this organization shall be personally liable to its creditors for any indebtedness, or liability, and any and all creditors shall look only to the assets of this organization for payment.” be added to Article III: Membership. **Rationale:** The bylaws do not currently include any language that protects the officers. This Section would add such language. Bylaws Committee. **Motion Failed.**

Motion # 2004-25. That “In addition, the immediate past president shall serve as a member of the board of directors for one year.” be added to Article V: Officers, Section I: Board of Directors, 1. **Rationale:** The immediate past president position would be able to provide the incoming board the benefit of their experience. Bylaws Committee. Motion **amended** to read: That “in addition, the immediate past president may serve as an ex officio member of the board of directors for one year.” be added to Article V: Officers, Section I: Board of Directors, 1. **Motion Referred to the Bylaws Committee.**

Motion # 2004-26. That “3. Election and Commencement of Office A. The president, recording secretary, and corresponding secretary shall be elected at a meeting of the membership held in odd numbered years and commence on July 1 of the following even numbered year. B. Terms of office for vice president, and treasurer shall be elected at a meeting of the membership held in even numbered years and commence on July 1 of the following odd numbered year.” be added to Article V: Officers, Section I: Board of Directors. **Rationale:** Currently the entire executive board of directors is elected at one time. Staggering the election process would provide for more

continuity and lessen the possibility that positions would be left vacant. Bylaws Committee.
Motion Referred to the Bylaws Committee.
